

Youth Month Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN

Purchase does not increase chance of winning.

The prize: One (1) prize of \$100 will be awarded via random drawing to one member at each Parkside branch (Westland, Livonia, Dearborn) from all eligible entries at that branch. Prize money will be deposited directly into the Youth account holder's account at Parkside Credit Union. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner.

How to enter: Parkside Credit Union members may enter by opening a Youth Account at Parkside Credit Union.

Terms and Conditions

1. **By submitting an entry, you fully and unconditionally agree to and accept these Official Rules.**
2. **Sweepstakes entries are limited to the United States and District of Columbia and is void where prohibited.** All federal, state and local laws and regulations apply. Subject to any governmental approval that may be required, Sponsor reserves the right to, without prior notice and at any time, terminate the Sweepstakes, in whole or in part, or modify Sweepstakes in any way, should any factor interfere with its proper conduct as contemplated by these Official Rules. Sweepstakes will begin at 9 a.m. on April 1, 2023 and will close at 5 p.m. on April 21, 2023. Sponsor reserves the right in its sole discretion, to cancel the sweepstakes in its entirety, or only select portions, if it becomes technically corrupted or because of non-authorized human intervention.
3. **Eligibility.** Must be a Parkside Credit Union member to enter. Employees, officers, or directors of Sponsor are ineligible to participate. No purchase necessary. Sweepstakes is open only to legal residents of the United States.
4. **Effective date of entries.** Sweepstakes entries will be effective on the day received. All entries become the exclusive property of Parkside Credit Union and will not be acknowledged or returned.
5. **Selection of winners.** One winner from each branch will be determined by random drawing from all eligible entries at that branch. Drawing will be held as soon as is commercially reasonable. Winners must agree to the use of their name, voice, and/or likeness for the purpose of advertising, trade, or promotion without further compensation, unless prohibited by law.
6. **Notification of winners.** Sweepstakes winner will be notified via email or phone.
7. **Odds of winning.** The odds of winning any drawing will be determined by the number of eligible entries received.
8. **Other conditions.** Sponsor, its agents and representatives, its affiliates, advertising, promotion and fulfillment agencies and legal advisors are not responsible for and will not be liable for (I) late, lost, damaged, misdirected, incomplete, unintelligible or postage due entries; (II) telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures or difficulties of any kind; (III) failed, incomplete, garbled or delayed computer transmissions; (IV) any condition caused by events beyond the control of Sponsor that may cause Sweepstakes to be disrupted or corrupted; (V) any injuries losses or damages of any kind arising in connection with or as a result of the Sweepstakes, or from participation in the Sweepstakes; or (VI) any printing or typographical error in any material associated with the Sweepstakes.
9. **Indemnification.** You agree to release and hold Sponsor, its employees, officers, directors, representatives, affiliates, advertising, promotion and fulfillment agencies, and legal advisors, harmless from any and all losses, damages, rights, claims and actions of any kind in connection with the Sweepstakes, including without limitation, personal injury, death and property damage, and claims based on publicity rights, defamation or invasion of privacy.
